

INVITATION FOR BIDS (IFB) HURGHADA PHOTOVOLTAIC POWER PLANT PROJECT (Loan Agreement No.: EG-P38 dated 29 February 2016, IFB Reference No. 1)

Pursuant to the rules for Japanese Official Development Assistance (ODA) Loans, New & Renewable Energy Authority (NREA) as the Employer, now invites eligible Bidders to participate in the International Competitive Bidding (ICB) process, following the procedures specified in the Guidelines for Procurement under Japanese ODA Loans published in April 2012 and the Operational Rules of STEP published on 21 December 2018 by JICA, for the Design, Execution and Completion of 20 MW Hurghada Photovoltaic Power Plant and Associated Works and Operations & Maintenance (O&M)Services during Defects Notification Period

- The New & Renewable Energy Authority has received a STEP (Special Terms for Economic Partnership) loan from Japan International Cooperation Agency (JICA) towards the cost of the Hurghada Photovoltaic Power Plant Project (hereinafter referred to as "the Project"). It is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract for the Project.
- Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans published in April 2012 and the Operational Rules of STEP published on 21 December 2018 by JICA, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
- The New & Renewable Energy Authority now invites sealed Bids from eligible Bidders for Engineering, Procurement, and Construction of the 20 MW Hurghada photovoltaic power plant, with a battery system with capacity 30 Mwh, with O&M services for a period of 2 years, in addition to construct an information center for renewable energy as turnkey ("the Works"). The Works comprise the Works to be implemented on a design and build lumpsum basis (the "Design Build Portion") and the Works to be implemented based on the Employer-furnished detailed design on a unit price basis (the "Build-Only Portion"). Proposals for the O&M Services for a period of two (2) years during the Defects Notification Period is invited as an integral part of this bidding. In addition, Proposals for the optional O&M Services for a period of three (3) years following the 2-year Defects Notification Period is also invited for reference purpose only. International Competitive Bidding (ICB) will be conducted in accordance with JICA's Single-Stage Two-Envelope Bidding Procedure (Without Prequalification).
